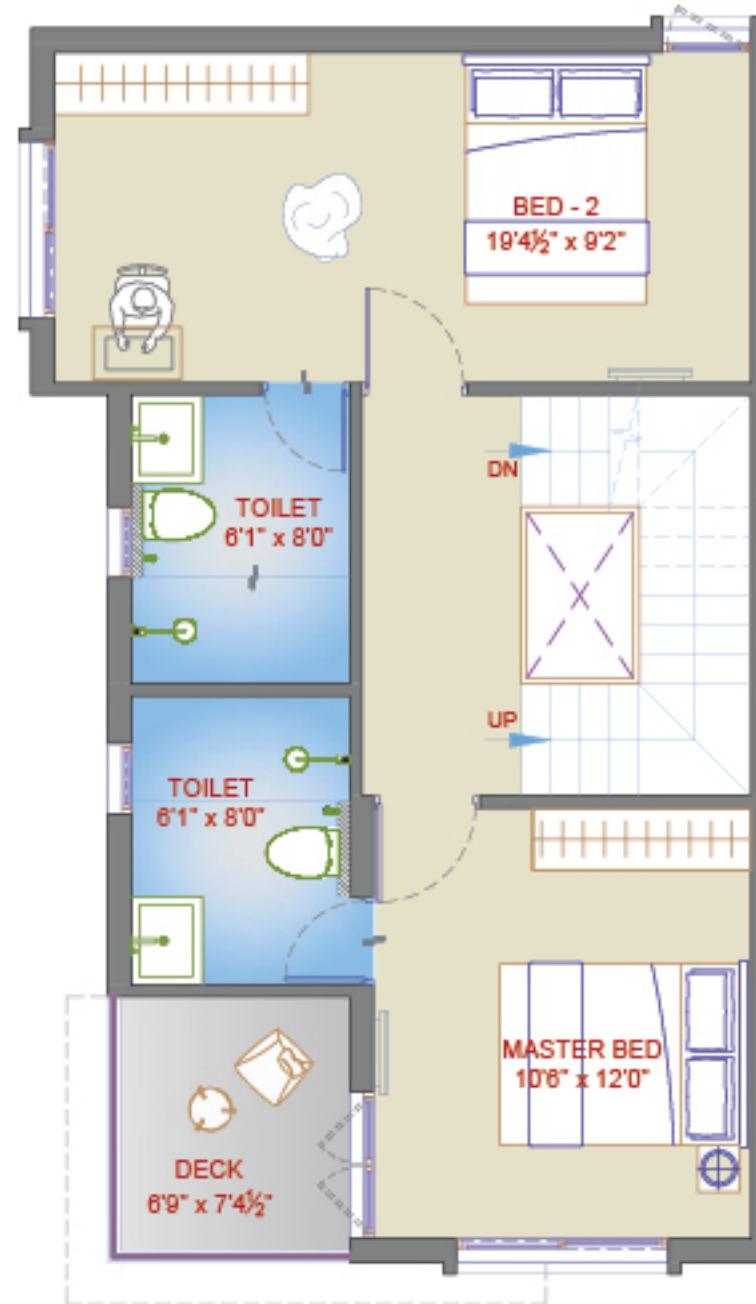


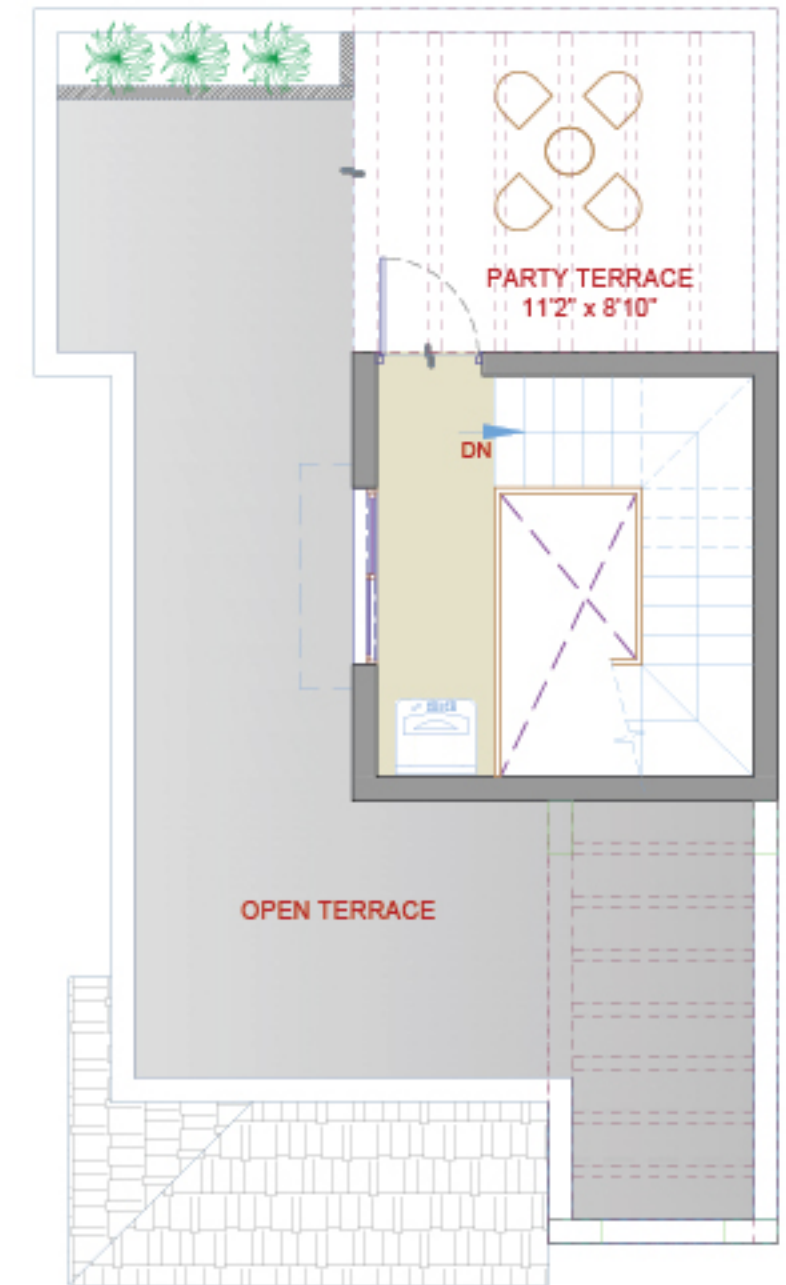

FIRST FLOOR PLAN



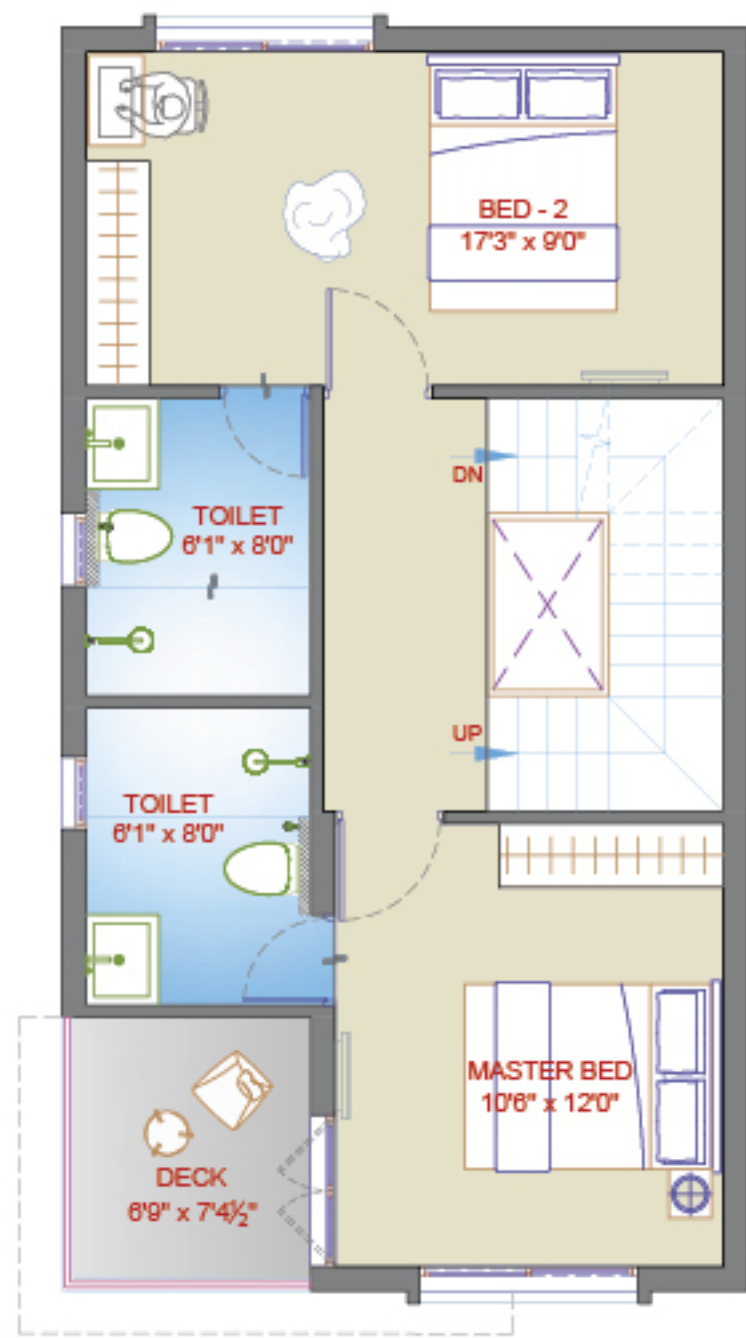

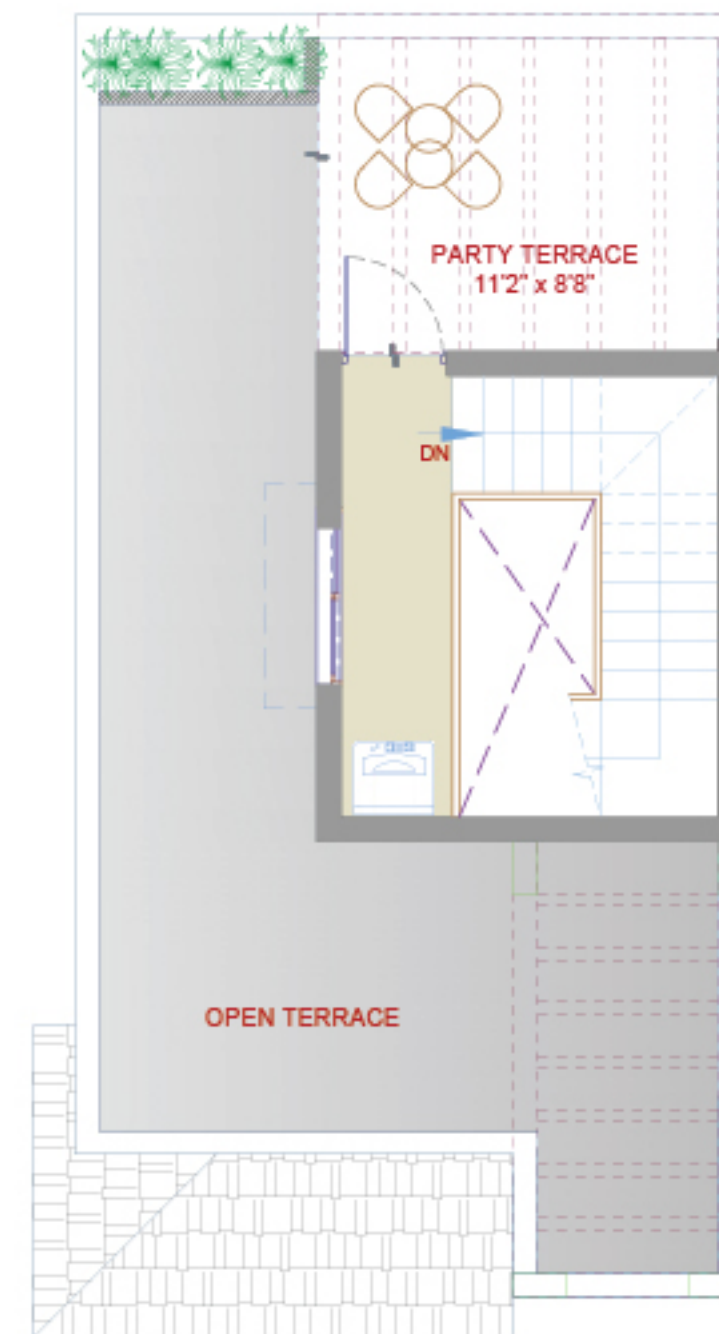




SITE CUM GROUND FLOOR PLAN

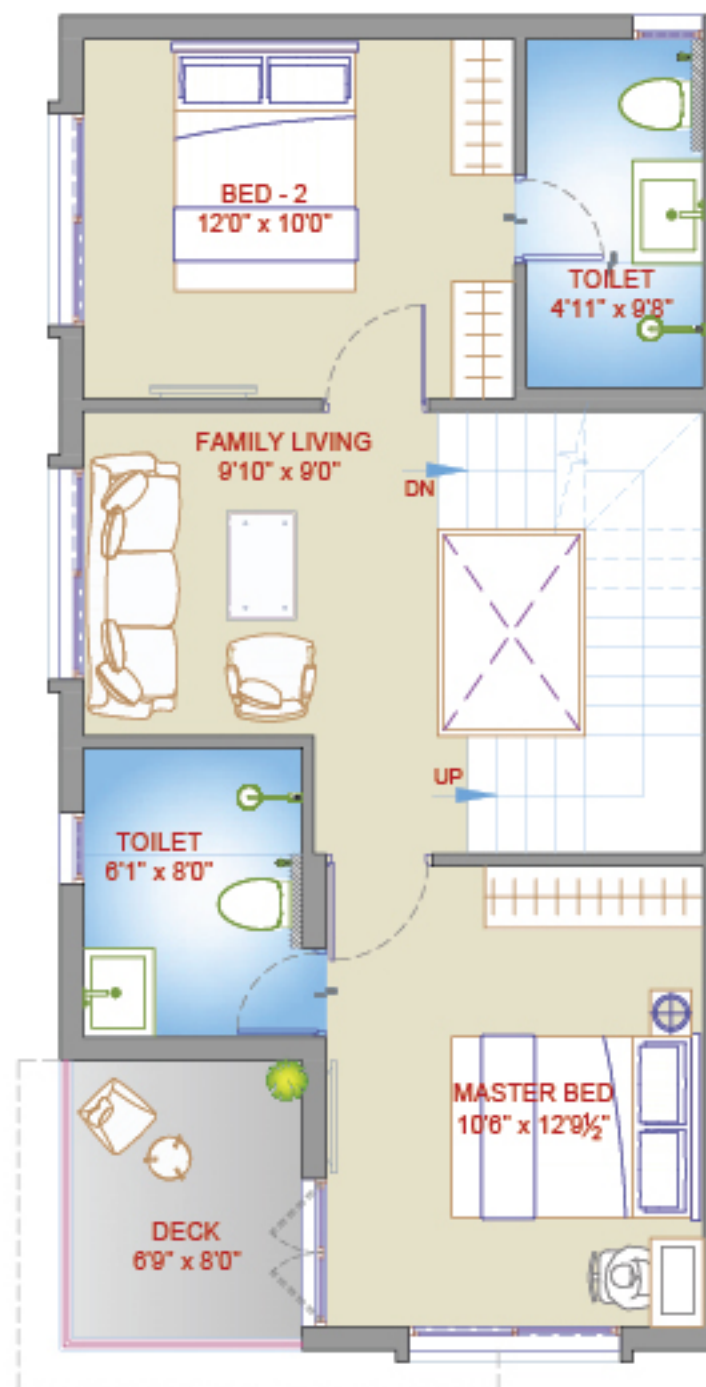

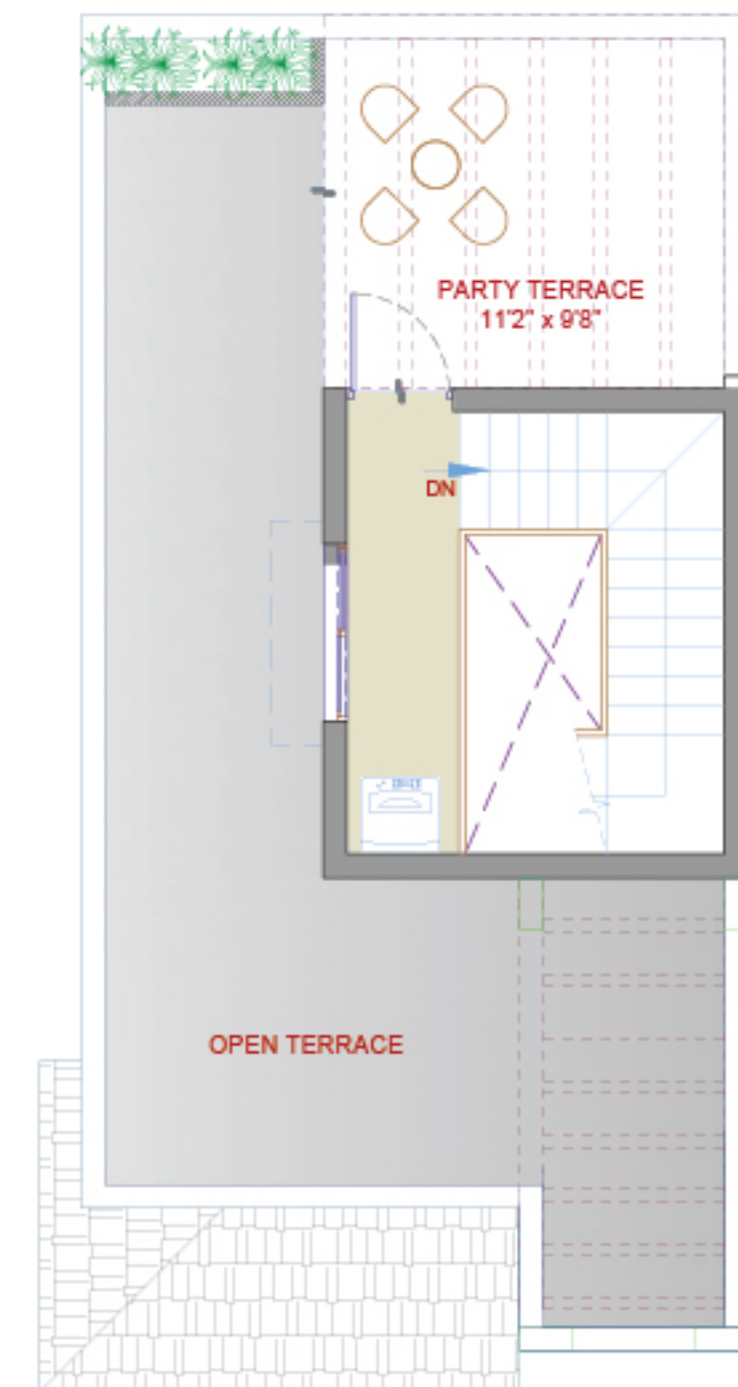

SITE CUM GROUND FLOOR PLAN



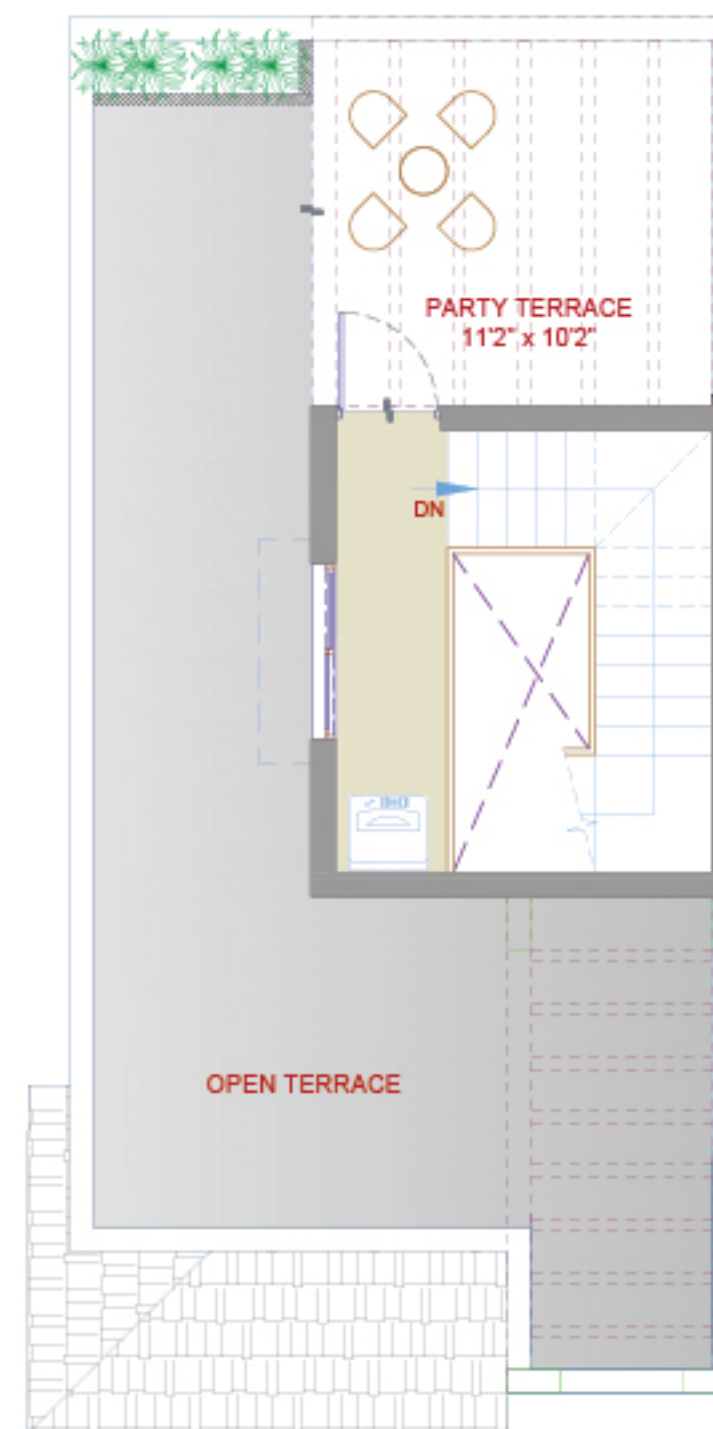
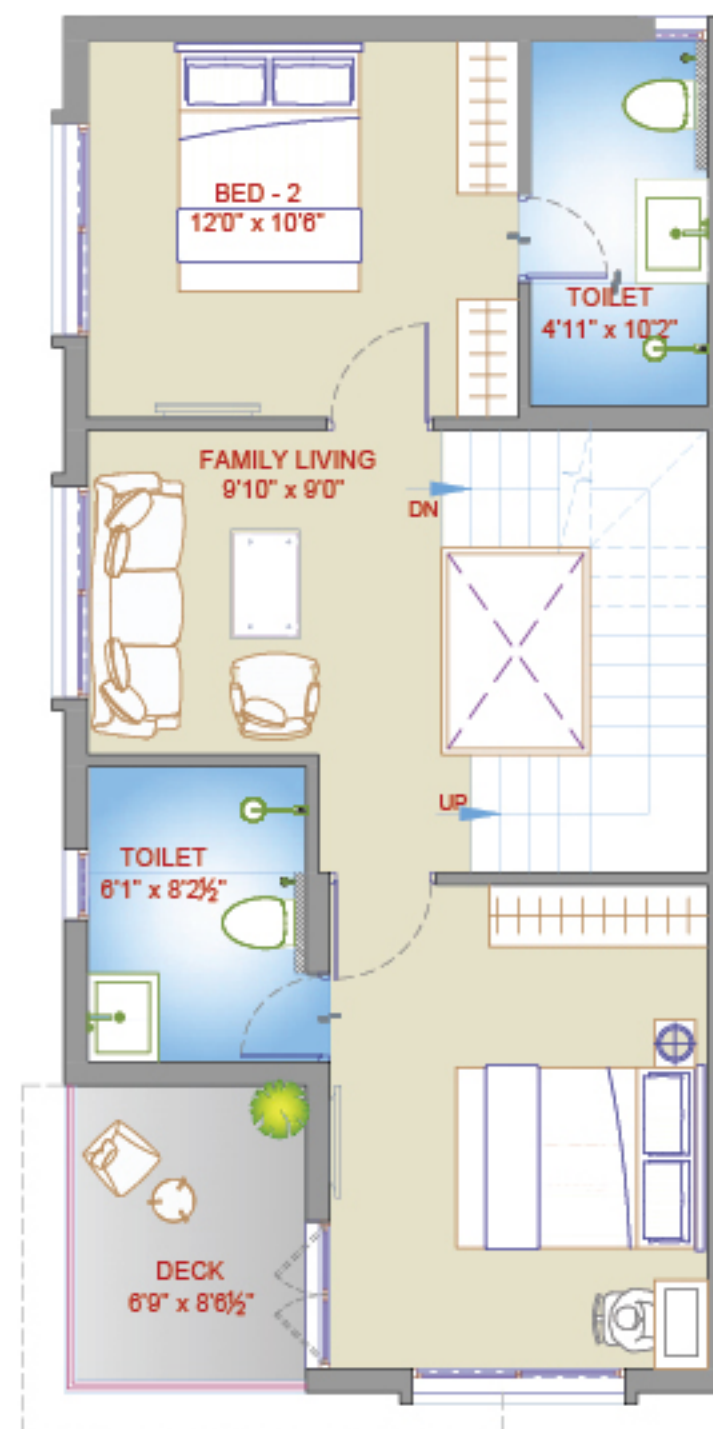

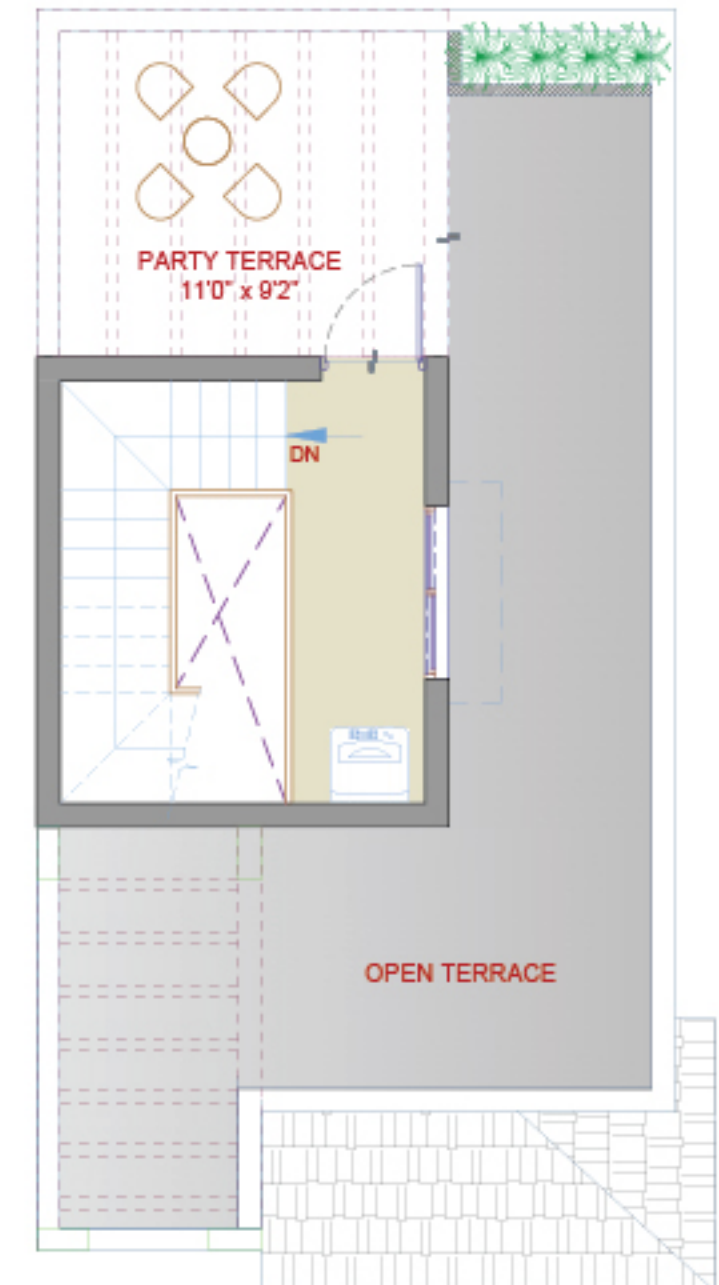




SITE CUM GROUND FLOOR PLAN



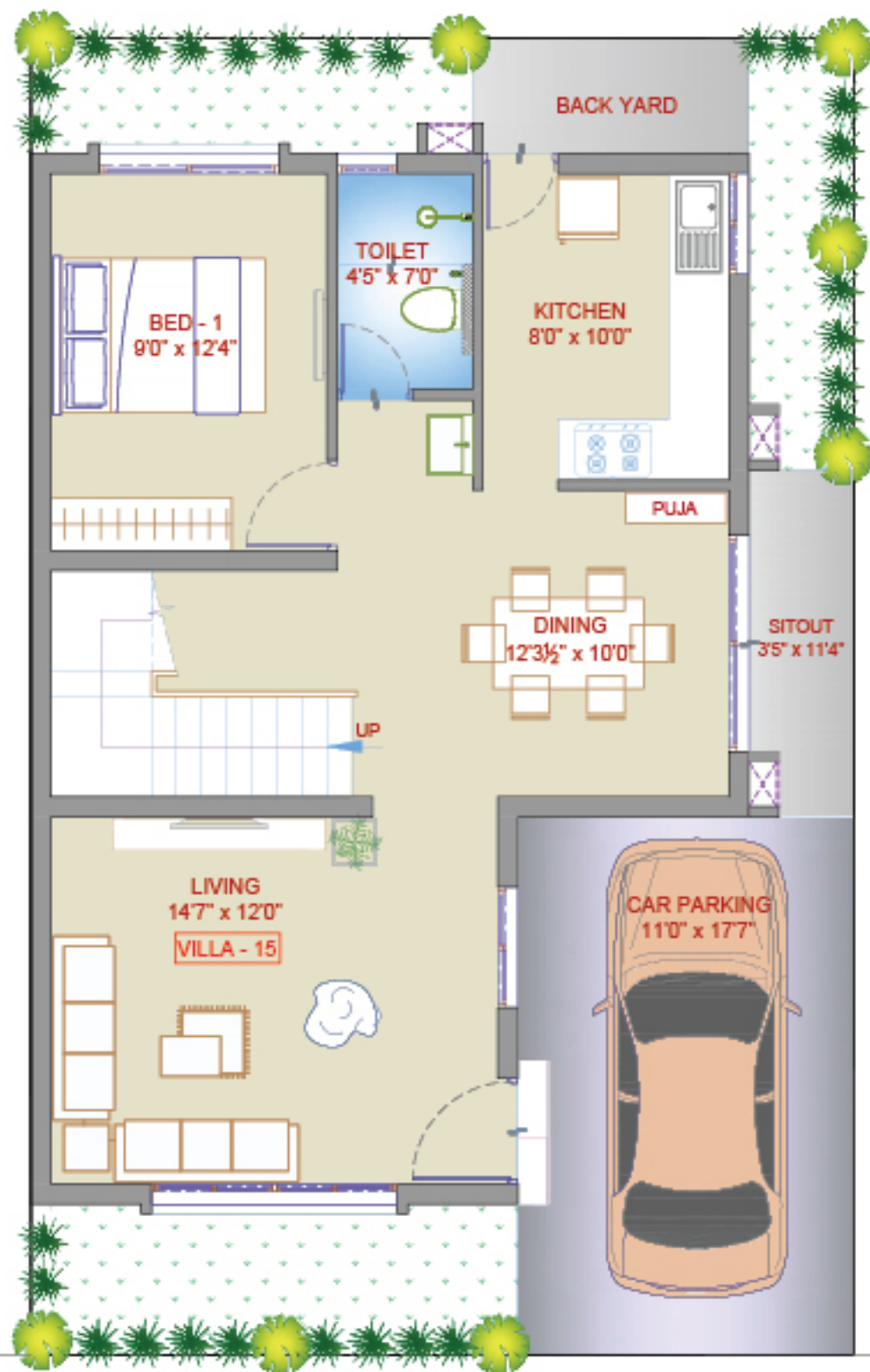

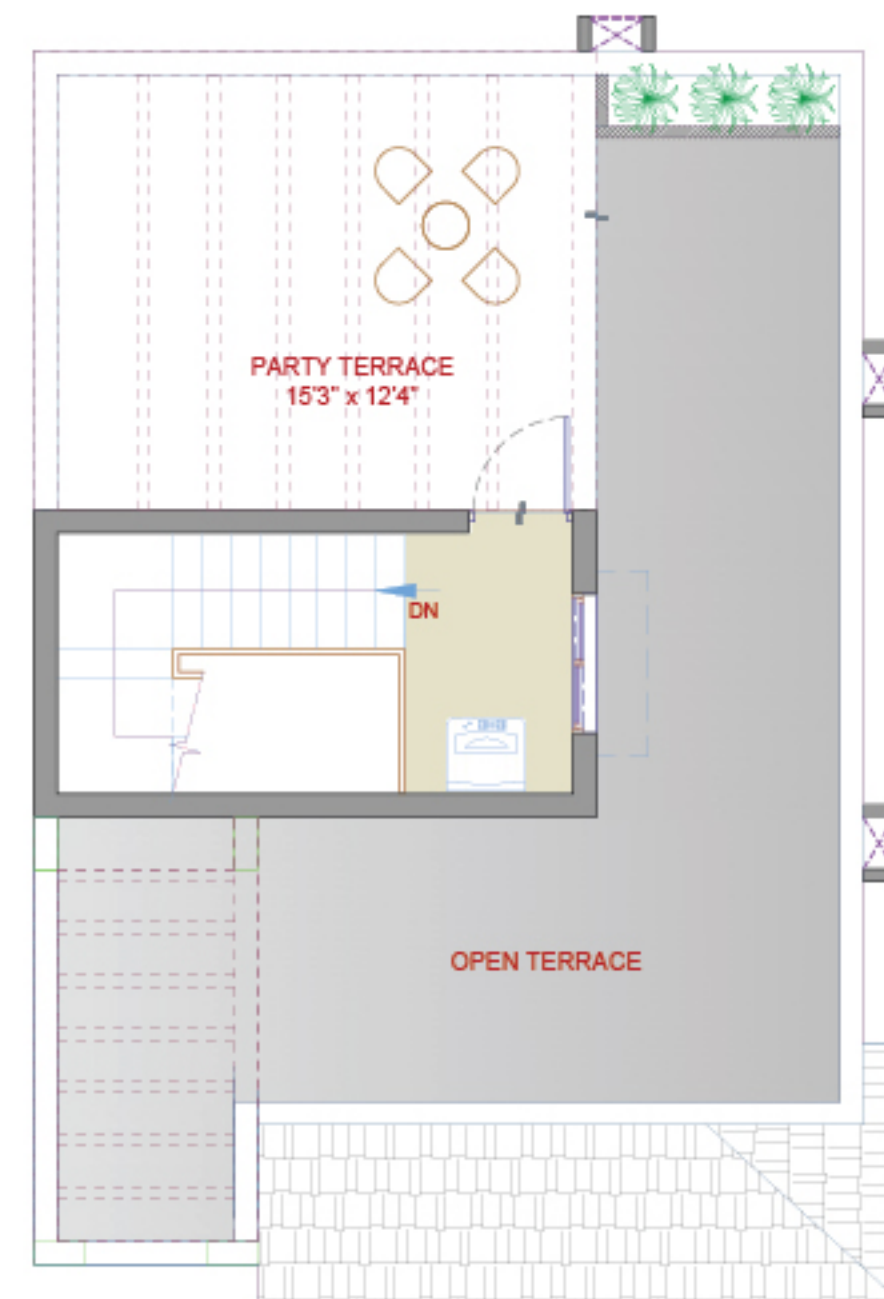




SITE CUM GROUND FLOOR PLAN

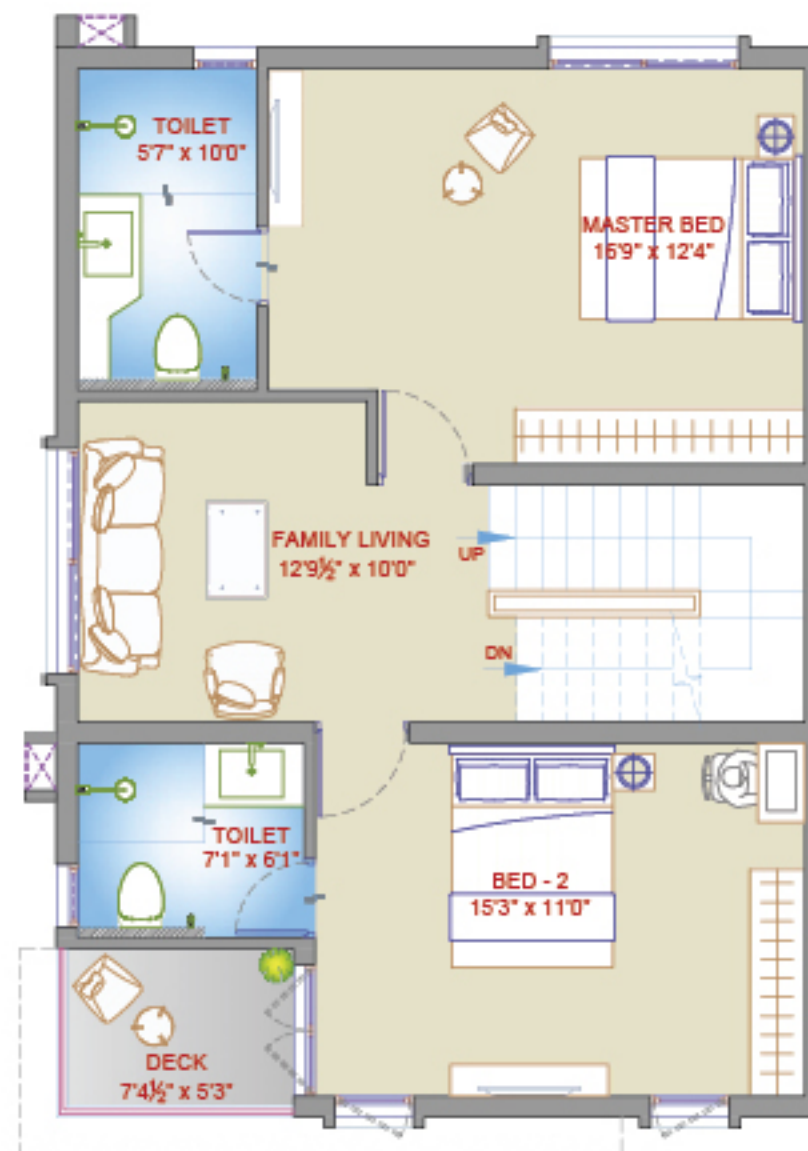

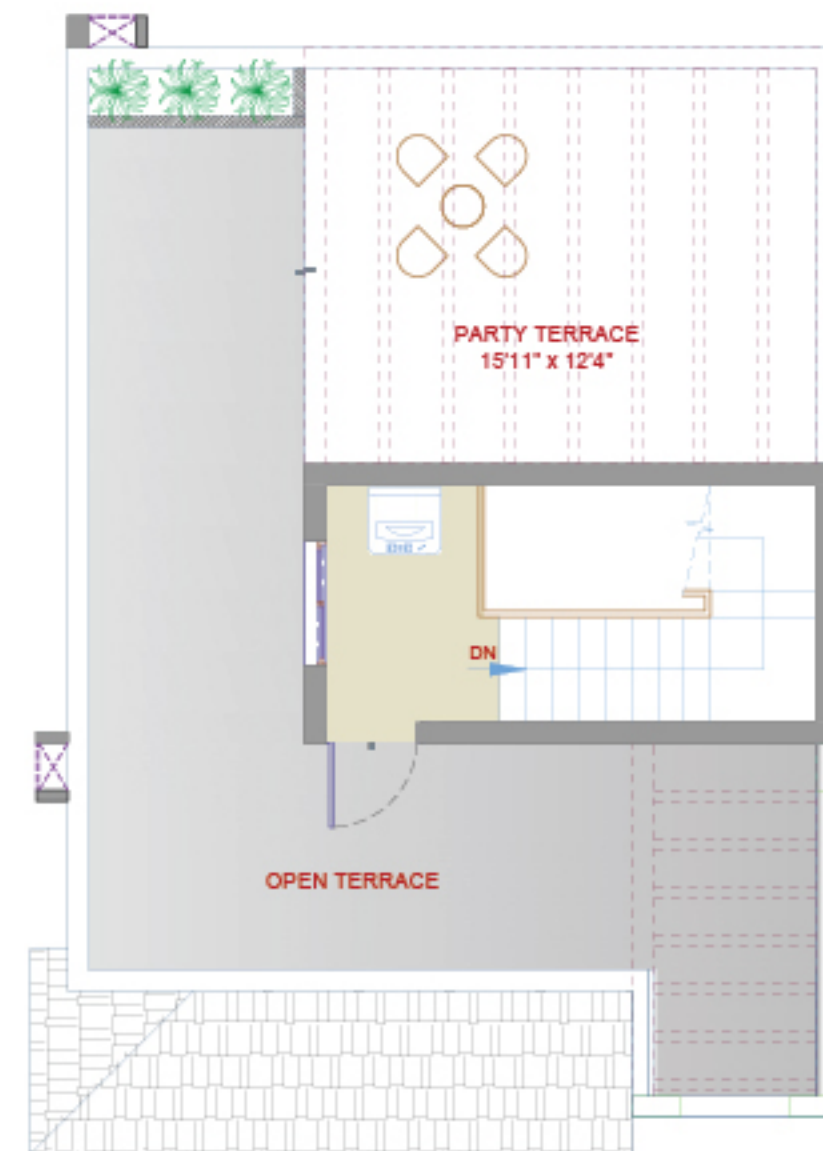




SITE CUM GROUND FLOOR PLAN

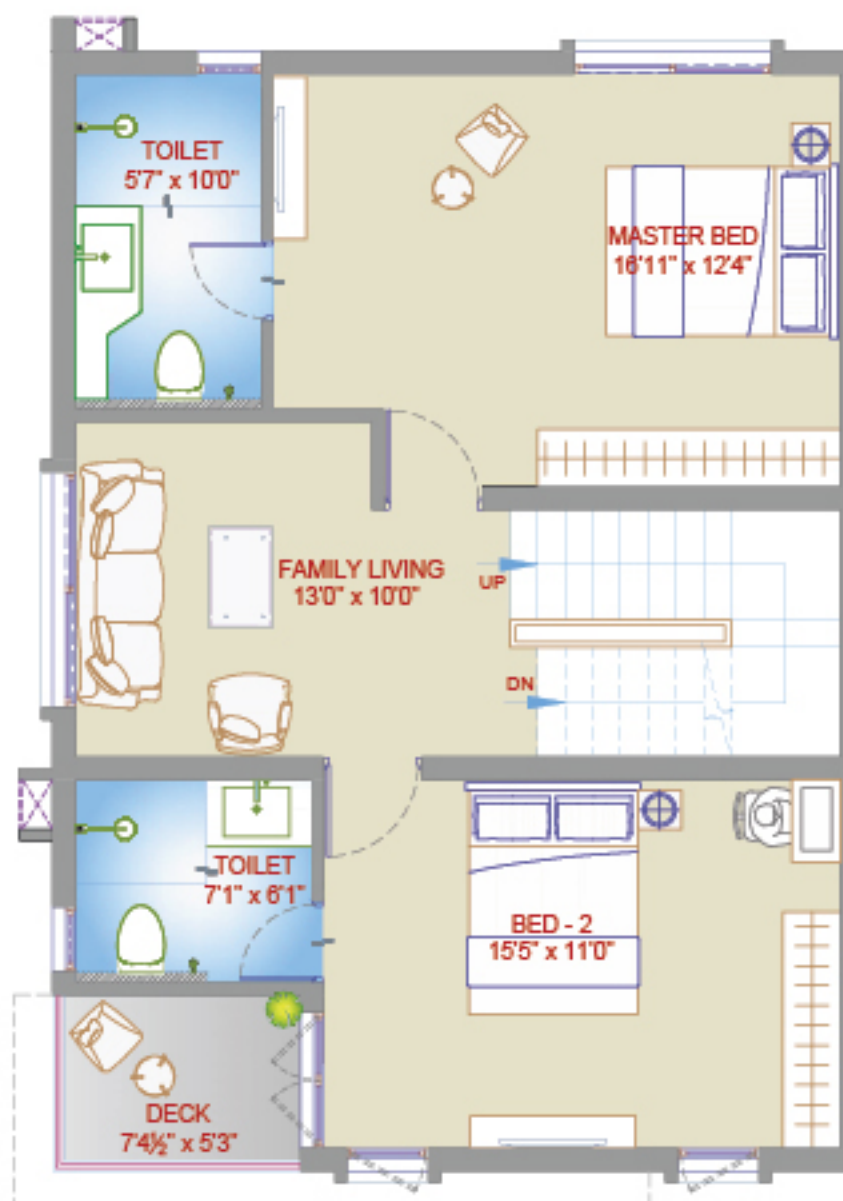

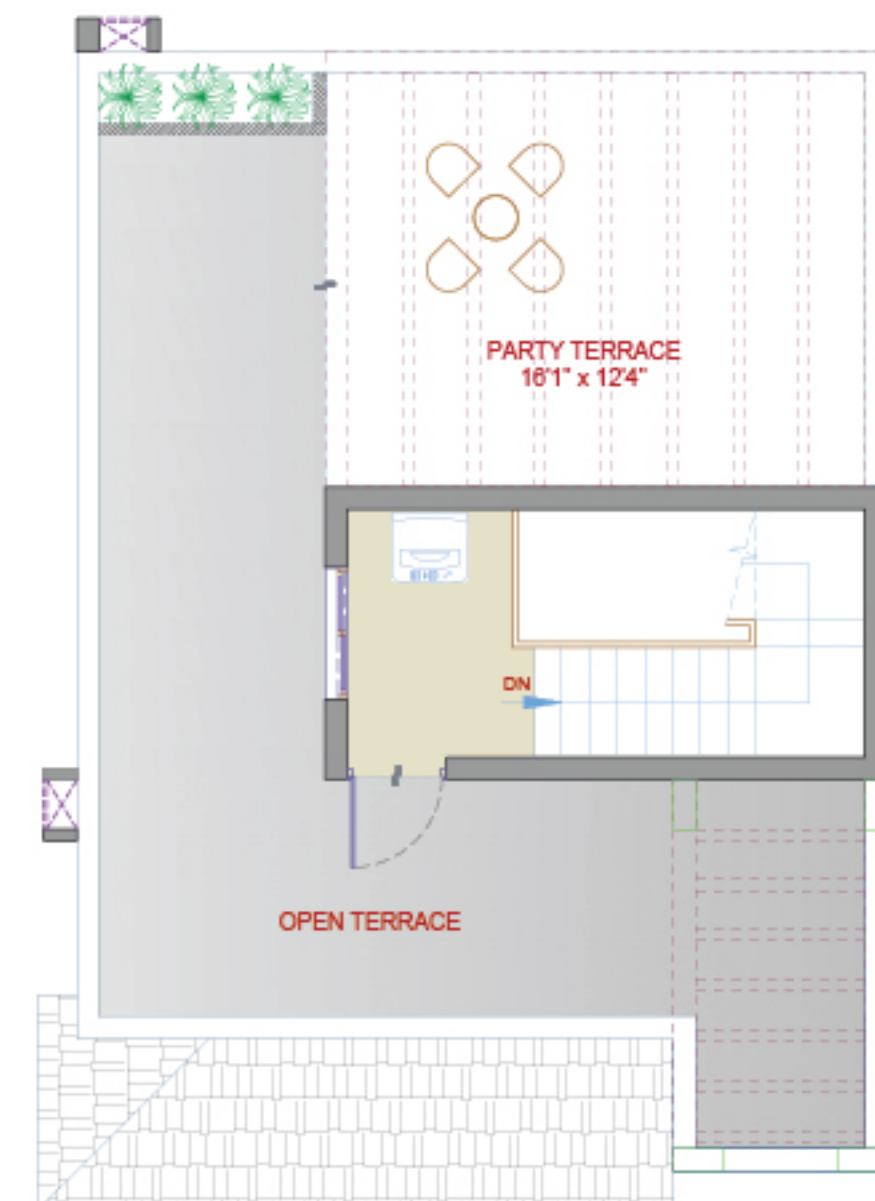




SITE CUM GROUND FLOOR PLAN

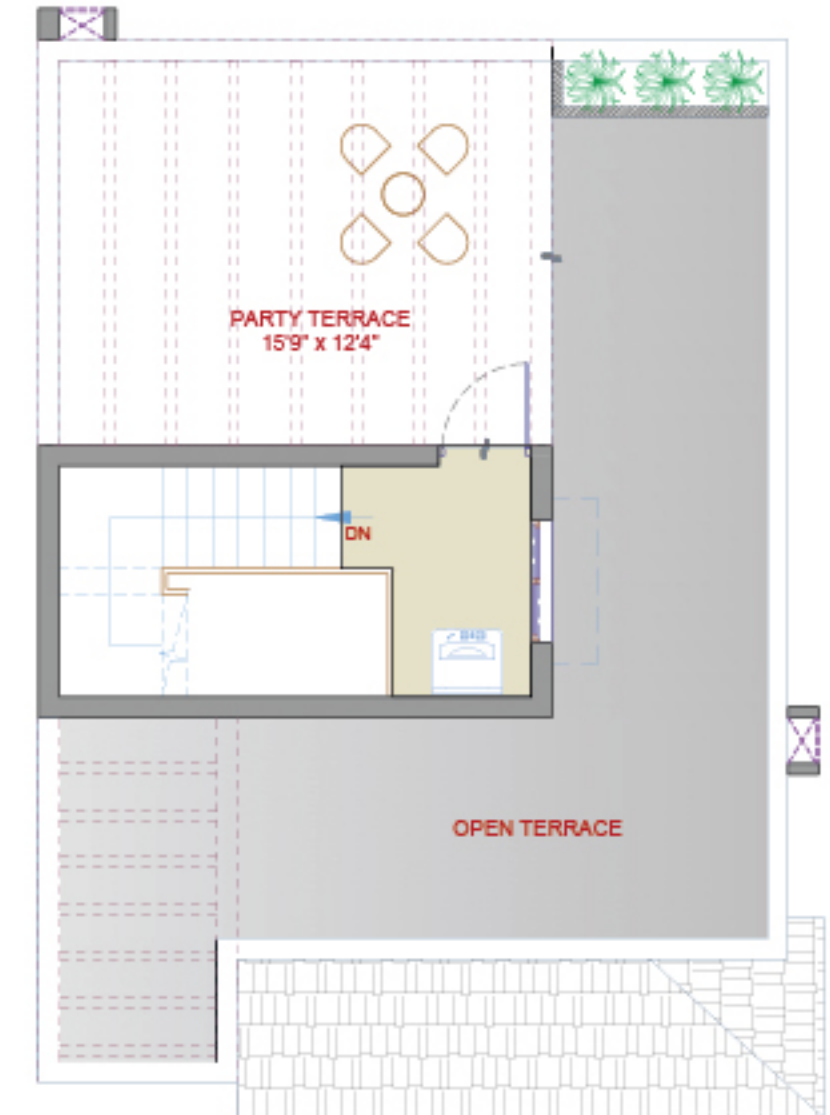




SITE CUM GROUND FLOOR PLAN

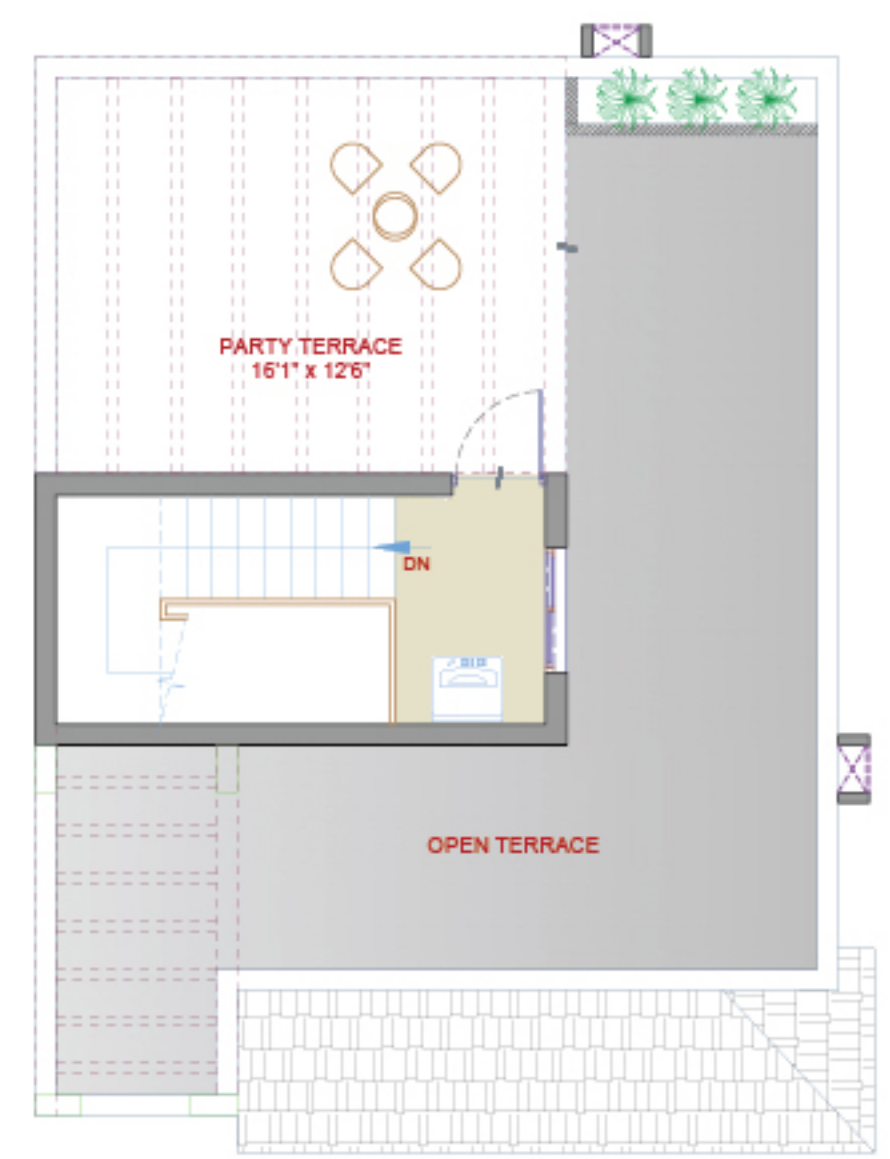




SITE CUM GROUND FLOOR PLAN

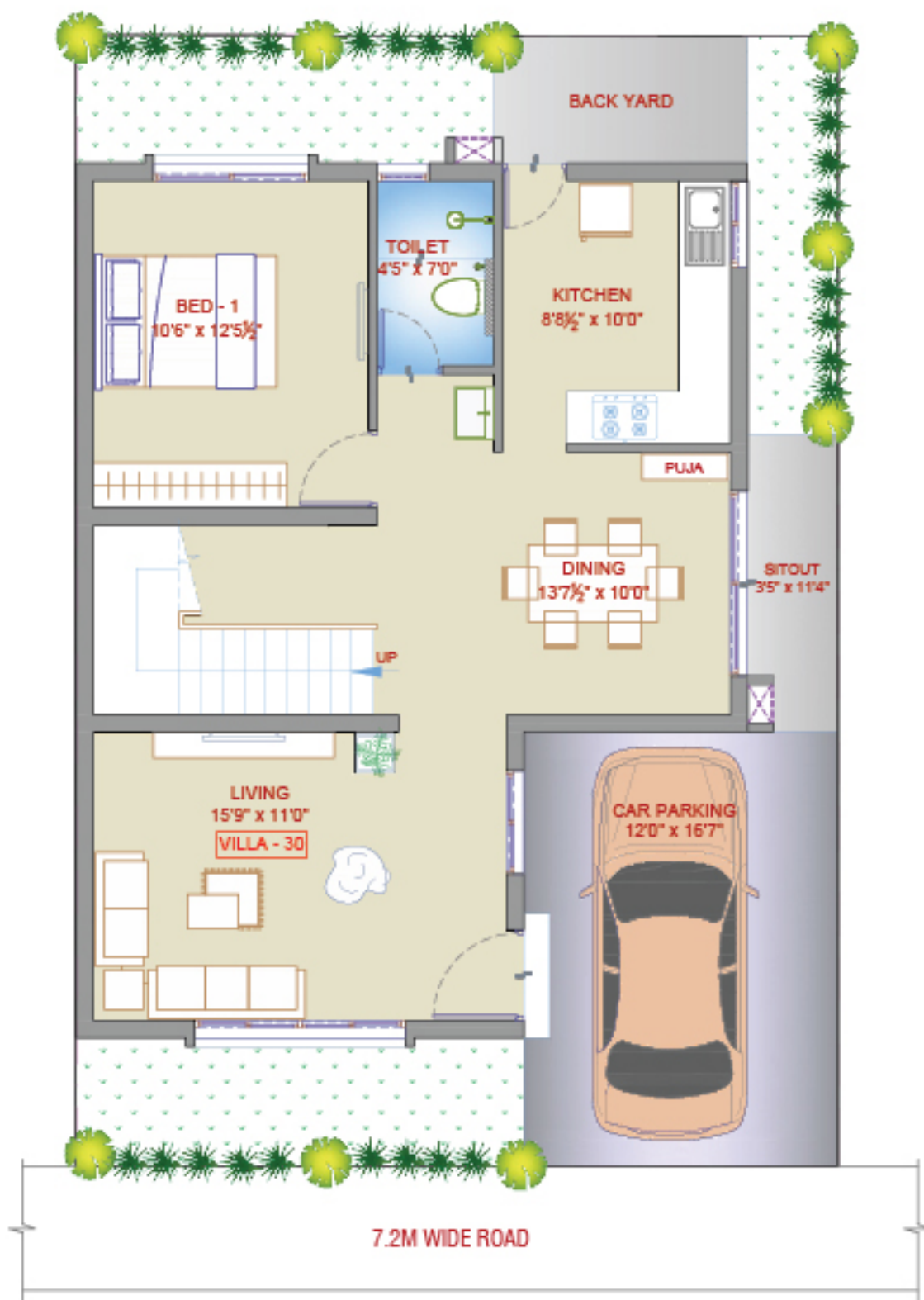

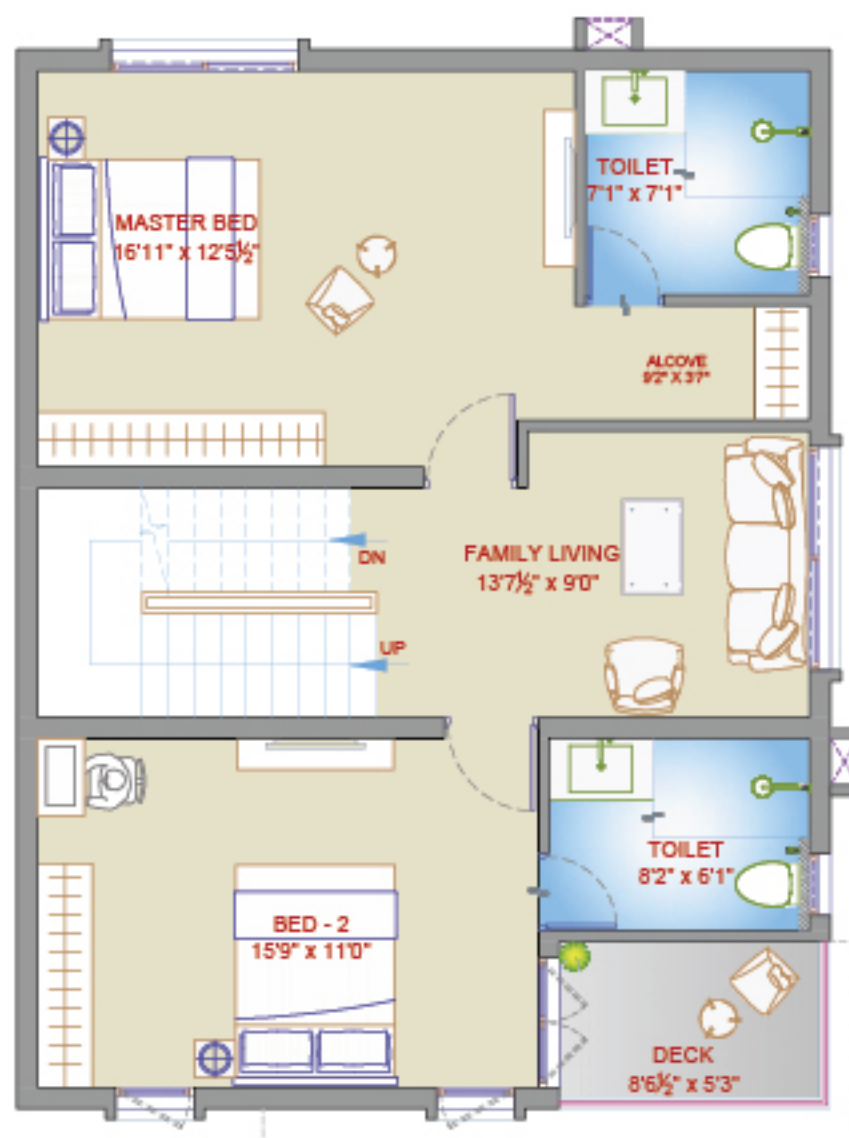

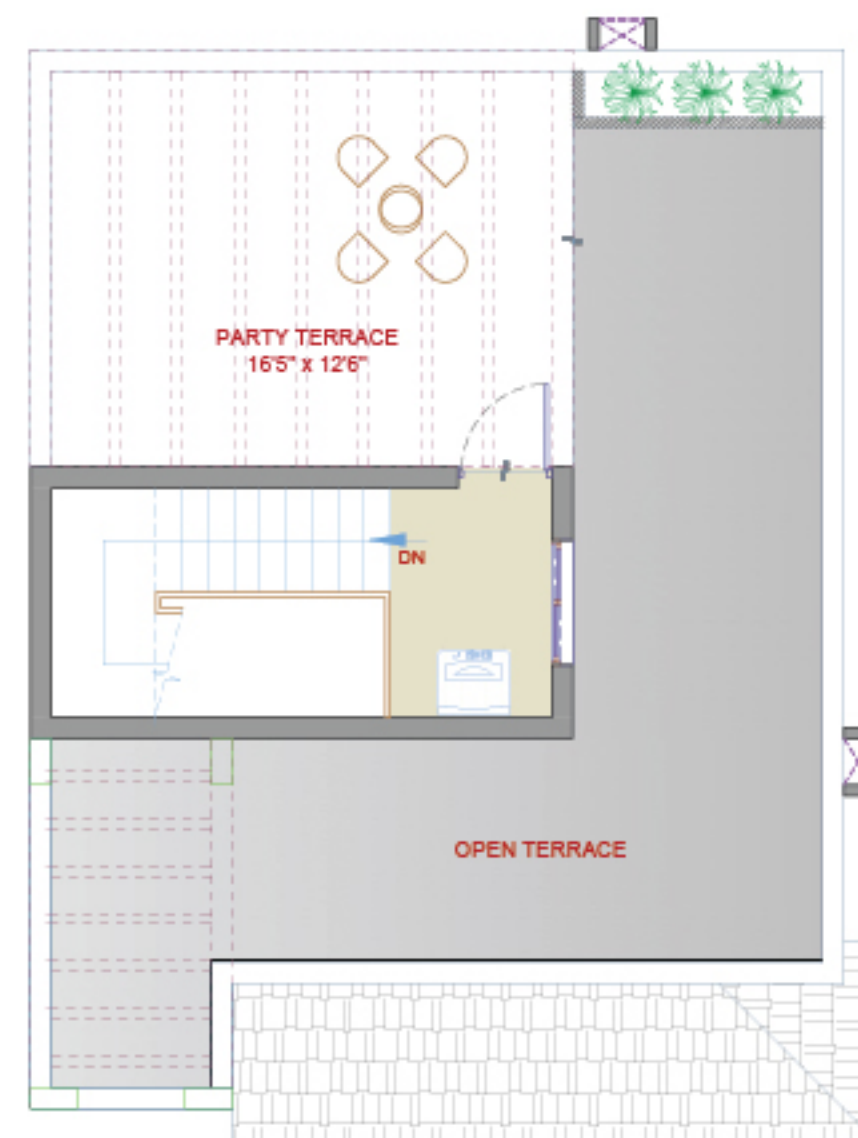




SITE CUM GROUND FLOOR PLAN

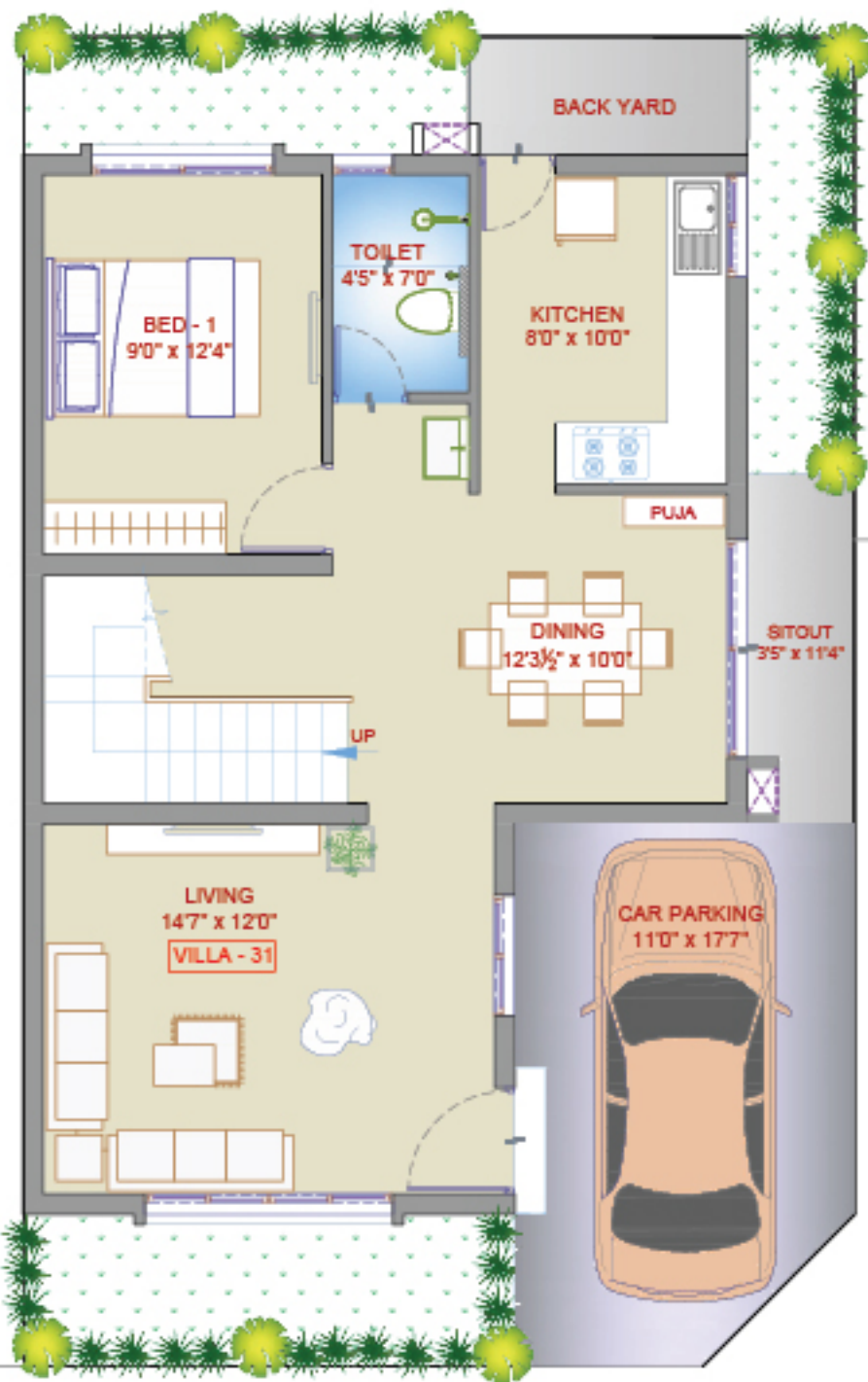

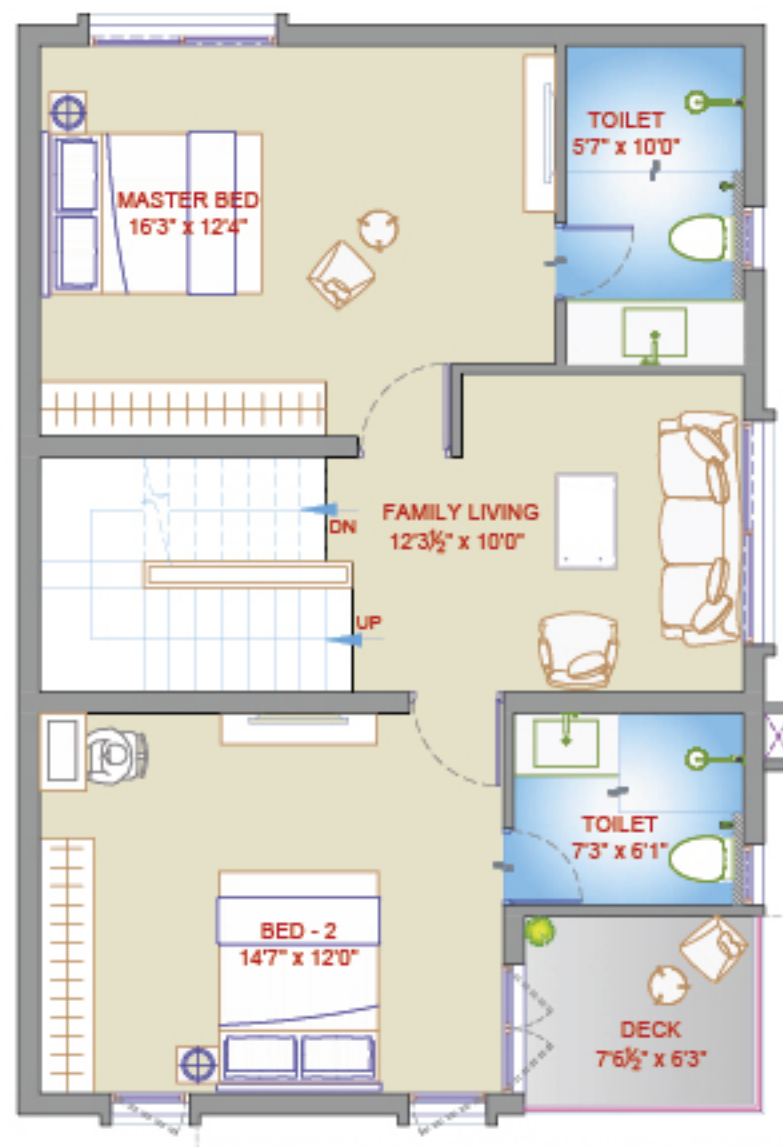

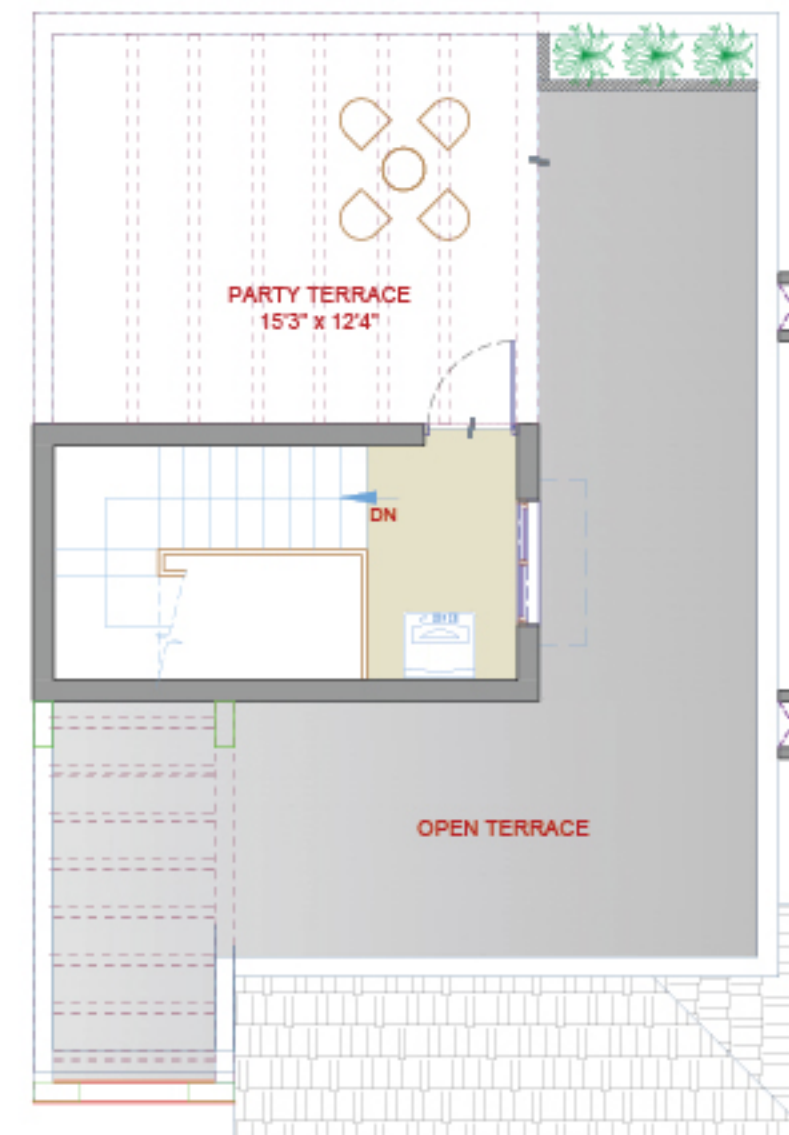




SITE CUM GROUND FLOOR PLAN
